

DELAWARE TOWNSHIP
ORDINANCE #2015-07

AN ORDINANCE OF THE TOWNSHIP OF DELAWARE, COUNTY OF HUNTERDON, AND STATE OF NEW JERSEY TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR ROAD DRAINAGE AND CONSTRUCTION IN THE AMOUNT OF \$70,000.00; AND TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF VARIOUS ROAD EQUIPMENT IN THE AMOUNT OF \$40,000.00; AND AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR IMPROVEMENTS TO DILTS FARM PARK IN THE AMOUNT OF \$3,000.00. #2015-07

BE IT ORDAINED by the Township Committee of the Township of Delaware, County of Hunterdon and State of New Jersey as follows:

Section 1. Delaware Township has a need to chip, tar and improve various roads in Delaware Township. Delaware Township hereby authorizes an appropriation and expenditure for labor and materials for improvements to various township roads, in an amount not to exceed \$70,000.00.

Section 2. Delaware Township has a need to purchase various road equipment for our road department in order to maintain all township roads. Delaware Township hereby authorizes an appropriation and expenditure for the purchase of various road equipment in an amount not to exceed \$40,000.00.

Section 3. Delaware Township has a need to maintain and improve the basketball and tennis courts at Dilts Farm Park. Delaware Township hereby authorizes an appropriation and expenditure for the purchase of materials and labor to improve and maintain the basketball and tennis courts in an amount not to exceed \$3,000.00.

Section 4. Total amount to be expended from Reserve for Road Drainage and Construction shall not exceed \$70,000.00.

Section 5. Total amount to be expended from Reserve for the Purchase of Various Road Equipment shall not exceed \$40,000.00.

Section 6. Total amount to be expended from Reserve for Improvements to Dilts Farm Park shall not exceed \$3,000.00.

Section 7. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.
