

DELAWARE TOWNSHIP
ORDINANCE #2016-10

AN ORDINANCE OF THE TOWNSHIP OF DELAWARE, COUNTY OF HUNTERDON, AND STATE OF NEW JERSEY TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF A FOUR-WHEEL DRIVE VEHICLE IN THE AMOUNT OF \$3,000.00; AND TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF ROAD CONSTRUCTION AND DRAINAGE IN THE AMOUNT OF \$40,000.00; AND TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF POLICE EQUIPMENT IN THE AMOUNT OF \$10,000.00.

BE IT ORDAINED by the Township Committee of the Township of Delaware, County of Hunterdon and State of New Jersey as follows:

Section 1. Delaware Township has an annual lease payment for the 2013 Chevy Tahoe police vehicle. Delaware Township hereby authorizes an appropriation and expenditure for payment of the annual lease, in an amount not to exceed \$3,000.00; and,

Section 2. Delaware Township has a need to chip, tar and improve various roads in Delaware Township. Delaware Township hereby authorizes an appropriation and expenditure for labor and materials for improvements to various township roads, in an amount not to exceed \$40,000.00; and,

Section 3. Delaware Township has a need to lease purchase a 2016 Police Interceptor Sedan for the Police Department. Delaware Township hereby authorizes an appropriation and expenditure for the lease purchase of a 2016 Police Interceptor Sedan in an amount not to exceed \$10,000.00; and,

Section 4. Total amount to be expended from Reserve for the Purchase of a Four-Wheel Drive Vehicle shall not exceed \$3,000.00.

Section 5. Total amount to be expended from Reserve for the Purchase of Road Construction and Drainage shall not exceed \$40,000.00.

Section 6. Total amount to be expended from the Reserve for the Purchase of Police Equipment shall not exceed \$10,000.00.

Section 7. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.
