

DELAWARE TOWNSHIP
ORDINANCE #2017-12

AN ORDINANCE OF THE TOWNSHIP OF DELAWARE, COUNTY OF HUNTERDON, AND STATE OF NEW JERSEY TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF ROAD IMPROVEMENTS IN THE AMOUNT OF \$133,021.23; TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF VARIOUS ROAD EQUIPMENT IN THE AMOUNT OF \$5,000.00 FOR THE PURCHASE OF RADIOS; TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM RESERVE FOR THE PURCHASE OF IMPROVEMENTS TO DILTS FARM IN THE AMOUNT OF \$5,000.00 FOR THE PURCHASE OF VARIOUS ATHLETIC EQUIPMENT FOR DILTS PARK SPORTING EVENTS; AND AN EXPENDITURE AND APPROPRIATION FROM THE CAPITAL IMPROVEMENT FUND IN THE AMOUNT OF \$2,200.00 FOR A FIXED ASSET INVENTORY FOR DELAWARE TOWNSHIP.

BE IT ORDAINED by the Township Committee of the Township of Delaware, County of Hunterdon, and State of New Jersey as follows:

Section 1. Delaware Township has a need to chip, tar and make improvement on various roads in Delaware Township in order to maintain our road system. Delaware Township hereby authorizes an appropriation and expenditure for labor and materials to make improvements on various township roads, in an amount not to exceed \$133,021.23; and,

Section 2. Delaware Township has a need to purchase two way radios for the Road Department in order to improve communication when employees are at various job sites throughout the township. Delaware Township hereby authorizes an appropriation and expenditure from Reserve for the Purchase of Various Road Equipment, in an amount not to exceed \$5,000.00; and,

Section 3. Delaware Township has a need to purchase various athletic equipment for Dilts Farm Park, for the safety of all sports participants. Delaware Township hereby authorizes

an appropriation and expenditure from Reserve for the Purchase of Improvements to Dilts Farm in an amount not to exceed \$5,000.00; and,

Section 4. Delaware Township has a need to complete a thorough fixed asset inventory for the integrity of Delaware Township's various equipment and property holdings. Delaware Township hereby authorizes an appropriation and expenditure for documentation of all fixed assets owned by Delaware Township, from the Capital Improvement Fund, in an amount not to exceed \$2,200.00; and,

Section 5. Total amount to be expended from Reserve for Road Improvements shall not exceed \$133,021.23.

Section 6. Total amount to be expended from Reserve for the Purchase of Various Road Equipment shall not exceed \$5,000.00.

Section 7. Total amount to be expended from Reserve for the Purchase of Improvements to Dilts Farm shall not exceed \$5,000.00.

Section 8. Total amount to be expended from the Capital Improvement Fund shall not exceed \$2,200.00..

Section 9. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.
