

**DELAWARE TOWNSHIP**  
**ORDINANCE #2018-03**

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER VII (TRAFFIC) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF DELAWARE, COUNTY OF HUNTERDON AND STATE OF NEW JERSEY TO AMEND SCHEDULE I OF SECTION 7-3.3 "PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS" AND TO AMEND SCHEDULE IV OF SECTION 7-3.6 "PARKING TIME LIMITED ON CERTAIN STREETS" AMEND #1998-21

BE IT ORDAINED by the Mayor and Township Committee of the Township of Delaware, County of Hunterdon and State of New Jersey as follows:

Section 1. Chapter VII Schedule I "No Parking" of Section 7-3.3 Parking Prohibited at all Times on Certain Streets of the Revised General Ordinances of the Township of Delaware shall be supplemented to include the following "No Parking" Zone:

<u>Name of Street</u>	<u>Sides</u>	<u>Location</u>
Hunterdon County Route 604 (Rosemont Ringoes Road)	East and West Bound	Within Fifty (50') Feet of the "STOP" Signs at the Intersection with County Route 523 (Sergeantsville Road) Pursuant to Title 39:4-138h
Hunterdon County Route 523	North and South Bound	Within Fifty (50') Feet of the "STOP" Signs at the Intersection with County Route 604 (Rosemont Ringoes Road) Pursuant to Title 39:4-138h

Quarry Road

Both Sides

1000 feet North from Rt. 29

Section 2. Chapter VII Schedule IV “Time Limit Parking” of Section 7-3.6 Parking Time Limited on Certain Streets of the Revised General Ordinances of the Township of Delaware shall be supplemented to include the following “Time Limit Parking” Zone:

Hunterdon County Route 604	West Bound	Fifteen (15) Minutes	12:00 a.m. to 11:59 p.m.	600 Rosemont Ringoos Road
Hunterdon County Route 604	West Bound	Fifteen (15) Minutes	12:00 a.m. to 11:59 p.m.	604 Rosemont Ringoos Road (parking space closest to intersection)

Section 3 A vehicle in violation will be subjected to a \$25.00 violation per offense and/or towed at the owner’s expense.

Section 4. Any and all Ordinances inconsistent with this Ordinance are hereby repealed to the extent of any such inconsistency.

Section 5. If any section, part of any section, or clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of the Revised General Ordinances. The Township Committee of the Township of Delaware declares that it would have passed the Ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional invalid.

Section 6. This Ordinance shall take effect upon final passage and publication as provided by law.
