Chair Szwed opened the meeting at 6:35 p.m., per the addition of a presentation, per the Annual Notice Resolution, #2, 01.20.22.

## Minutes: February 16, 2022

The minutes of the noted meeting were distributed prior to the meeting. Member Lockwood made a motion to approve the minutes for discussion. Member Kafarski seconded the motion. The minutes were reviewed. Said motion was approved by voice vote.

## Recycling – K. Klink

Member Klink reported that she is looking for data on the wages and expenditures related to Household Clean Up Day. She stated that with that data, a comparison of income vs. expenditures can be done.

## Open Space Committee – K. Katz

Member Katz stated that the Open Space Committee met on February 22. Member Katz noted that Christian Bench developed a flyer for information on farmland preservation. Member Katz noted that the flyer was reviewed and comments were provided to the Open Space Coordinator so that changes can be made.

Member Katz noted that at the next meeting, on Monday, March 20, the pamphlet will be reviewed again.

Member Katz noted that with the Penn East pipe no longer a proposed project, the SADC may look at farmland along the Penn East easement. She further reported that farms, like the Kohler farm on Lambertville Headquarters Road, were denied because of the Penn East easement on their farm. Member Katz further noted that the SADC is still sorting out the process, but that there is no forward movement on the pipeline properties.

Member Katz reported that the Farmland Preservation element needed for the reexamination will be worked on by the Open Space Committee. She stated that this topic will also be reviewed at Monday's meeting.

Member Katz reported that the Committee is contemplating a flyer for preserving open space that is also not farmland, to be followed by meetings for public outreach.

#### Planning Board – K. Katz

Member Katz reported that the Planning Board had a meeting in February to discuss the Trap Rock ten-year license renewal, including the reclamation plan. She noted that this renewal coincides with the Master Plan. She noted that the plan has not changed from the 2012 license and reclamation plan.

Member Katz stated that she will discuss with the Planning Board the idea of public meetings to discuss the Trap Rock renewal license.

Member Katz also discussed language change about easement monitoring. She noted that the Township Committee and the Township Attorney suggested that the language currently in the ordinance may need to be revised and clarified.

#### Easement Monitoring – M. Royal

Member Royal stated that the Easement Monitoring Subcommittee met and developed a letter to Township Committee to verify the accuracy of information that was provided concerning easement issues. Member Royal noted that once the language verification is given to the Commission, the Subcommittee will adjust the letter to property owners when a property is going to be monitored.

Member Royal also noted that the subcommittee was given information about recent sales of properties that have easements. She noted that the subcommittee will develop a "welcome" letter with information about the easement.

Member Royal reported that the subcommittee will meet again on March 30.

#### Schools – K. Klink

Member Klink reported that the School Green Team is hosting an Earth Day Celebration on April 14, 2022, 9:30 a.m. to 12:30 p.m. She noted that there will be various groups providing information about being green and sustainable.

It was suggested that the EC make the bluebird boxes available for order at this Celebration.

Member Klink reported that anyone who wants to help can contact her.

#### Grants – M. Royal, D. Polay

Member Polay reported that another ANJEC is available in the amount of \$1,500.00. Member Royal stated that it should be reviewed to see if there a project can be attached to this grant. Secretary Klink stated that there is a girl scout looking for a project for which this money can be applied. It was noted that this application is due May 2.

Secretary Klink reported that Member Polay has volunteered to help with Sustainable Jersey certification.

#### Website – J. Kafarski

Member Kafarski reported that the Quarter 1 and Quarter 2 topic will be the Ban the Bag project. Member Lockwood provided her email address to get the written information from the newsletter.

Member Kafarski stated that he reviewed the EC website and has found it easy to use. He also reviewed the Secaucus municipality website, which is developed by the same web developer. He noted that the external photo site used by Secaucus is flicker. He noted that it seems to be a boiler plate site for photos. Member Kafarski stated that he will do further research.

#### Stormwater Management – S. Lockwood

Member Lockwood reported on this committee. She noted that the committee has met and then changed their meeting date. Member Lockwood stated that the committee had a conversation and

discussion about the goals and objectives for this group. She noted that the group discussed grant opportunities, especially for plantings for Lower Creek Road and then received information from the Engineer that FEMA will cover the costs of those plantings. She noted that the group has no specific project at this time but would like to start a public outreach program.

Member Lockwood also noted that the Chairperson will be reaching out to neighboring communities to discuss coordinated information about the Wickecheoke and Lockatong Creeks, including the headwaters. There was some discussion about the Rose Creek project.

Member Lockwood stated that another project to be researched is encouraging rain gardens and/or rain barrels. She noted that part of the research can include someone with this type of expertise. She further noted that the Township Committee is interested in this education aspect.

#### Projects – Chair Szwed

Chair Szwed noted that he will probably start construction of bluebird boxes again. Secretary Klink reported that she will ask to see if order forms can be available at the Earth Day Celebration.

Secretary Klink reported that there is a Habitat Restoration Project at Bull's Island, with major planting to occur on April 30 and May 1.

Steve Willbur of Sandy Ridge Road was present. He asked about expanding trails on the other tract adjacent to Dilts Park, the tract that was the former Kean property, at the corner of Buchanan and Sandy Ridge Roads. Mr. Wilbur suggested that there could be a bird trail there, with boxes. He noted that this property does not have any backyards nearby.

Chair Szwed noted that a park planner is being hired to develop future plans for Dilts Park. He noted that the various Boards, Committees, and Commissions have been asked for input.

Member Lockwood seconded the motion that was unanimously approved by voice vote.
