The regular meeting of the Delaware Township Environmental Commission was held on the noted date, in the Delaware Township Municipal Building, 570 Rosemont Ringoes Road (County Route 604), Sergeantsville, New Jersey; supported by the ZOOM platform for virtual meetings. Chair Szwed opened the meeting at 7:30 p.m.

Chair Szwed read a statement noting that the requirements of the Open Public Meetings Act have been satisfied. **Minutes**: June 22, 2022

The minutes of the noted meeting were distributed prior to the meeting. Member Katz made a motion to approve the minutes for discussion. Member Polay seconded the motion. The minutes were discussed and approved as presented. Said motion was approved by voice vote, with abstentions by Members Lockwood and Royal.

## Presentation – pollinator garden at Dilts

Girl Scout Troop 80270 was represented by Leaders Stacey Grady and Ginny Lucas. Ms. Grady noted that their troop has six juniors who will be bridging to cadettes. It was noted that this troop wants to earn its bronze award by developing and installing a pollinator garden for solitary bees. Their presentation was given to the Township Committee, who asked that they come to the EC and discuss the best location.

The leaders noted that three location choices had been discussed with the TC. It was noted that Public Works likes the location along the split rail fence, near the gate for the entrance, also near the Pavilion. It was noted that location #3 is at the other entrance to Dilts, by the pond. It was noted that as this location is in the open, fencing would be needed all around. It was further noted that this location does not have as much visibility as the other two.

The leaders noted that the bulk of the project, including paperwork, must be done by September 30. The leaders stated that the Troop is excited about the project, including selection of native plants and building bee houses.

The three locations were discussed using a layout of Dilts Park. Ms. Grady noted that all locations will require fencing to delineate the area. She noted that fencing is one of the factors to help with finalizing the location and is a part of the budgeting for the project. She noted that the fencing will be split rail, to help keep out deer and other animals. She stated that the girls have thought of pavers as a small path through the garden. Ms. Grady noted that if Site #1 is chosen, it is along the mower shed requiring only three sides of fencing.

Member Locandro recommended 6-foot deer fencing on 8-foot metal poles. He noted that he could donate a roll of 50-foot fencing.

Member Katz asked about the width. The leaders noted that the garden would be 10 feet wide. The leaders also noted that there is an educational component to be added to the garden.

Chair Szwed asked about sunlight. Ms. Grady stated that in reviewing the sites with Member Klink, it was noted that this site, #2 near the mower shed has good southern exposure. Ms. Grady also noted that this site is close to one of the parking areas adding accessibility.

Member Katz discussed the benefits of this site, near the mower shed. It was noted that the economics of the fence are a factor, as is the visibility of the location to residents. The EC members agreed.

Diana Garibaldi of 142 Sandy Ridge Road was present. She asked about plants for all seasons and questioned the availability at this time of spring plants. The leaders agreed that the plants will be researched and selected for season-wide blooming, early spring to late fall.

Ms. Lucas also noted that the Troop is developing a maintenance plan. Ms. Grady stated that the troop members have been doing research at the County Library. Member Klink recommended Bowman's Hill Wildlife Preserve and noted that a former EC member works there, Donna Dahringer.

Ms. Lucas stated that seed could be planted for spring blooms. She noted that another goal of the project is for the project to be sustainable.

Ms. Garibaldi asked about the herbicide spraying that takes places at the park. She expressed her concern about the effect on the pollinators.

Member Kafarski stated that other methods for herbicide usage could be used that might be safer, one being mist spray. It was noted that the location of site #1, near the mower shed, might be somewhat protected against general field spraying.

Member Katz stated that the University of Ohio has a website about pollinators that is very informative and educational. She noted that the garden needs to have nectar sources and pollen sources.

Member Katz made a motion to approve site #1 as the choice location for the proposed pollinator garden. Member Kafarski seconded the motion. The letter of recommendation to the Township Committee follows the minutes.

## Dear TC:

At its meeting of July 20, 2022, the Environmental Commission (EC) discussed the project as recommended by the Township Committee at its meeting of July 11, 2022.

This Troop selected three sites for a pollinator garden designed for solitary bees and other native pollinators. The EC agreed with site #1, which is the location near the mower shed, at the edge of the parking lot nearest the Snack Shack. The Troop explained their selection of that site, based on three factors: accessibility by residents for educational purposes; future project of adding a mural on the wall of the mower shed for educational purposes; and expense of fencing to enclose the garden.

The EC discussed the issues and agreed with this location, adding two other factors: accessibility of water and sunlight. This site is southern facing, while site #2 is more shaded. Both sites have accessibility to water, but the EC agreed that this site seems more suitable to the project. This recommendation was moved, seconded and carried by the Environmental Commission on July 20, 2022.
